

# Reunification Checklist

## Assumptions

The campus is being closed and evacuated. Reunification is required for those who do not have a means of transportation from campus (public or private transport). These students are waiting to be picked up.

## General Campus Reunification- Grossmont

1. If on-campus traffic is restricted then general campus reunification will occur at the shopping center located between Hwy 125 and Lake Murray Blvd on Navajo.
2. If all vehicles have exited campus, then limited on-campus reunification traffic can occur via Griffin Drive Loop. The campus perimeter road will remain closed at Highwood and at the Griffin Drive-Perimeter exit.
3. If conditions require additional transportation resources, view the [list of vehicles assigned to Grossmont College](#) for possible transportation under the resources tab.
4. If transportation to the reunification location is needed, call MTA. They can help with a shuttle service.

## Child Development Center Reunification

1. CDC personnel and children will reunify at the CDC, unless required to move.
2. If the CDC is not available for reunification, then children and staff will be relocated to either Bldg 43 or Bldg 60. Notification of this move will be posted on the entrance to the CDC, and sent via the CDC parent notification plan.
3. If an off-campus location is required, then the staff and children will make their way to the LDS church [located off campus](#). The MOU to use the LDS facility is in place through 2017 and located in this tab.
4. A sworn peace officer or member of CAPS may be assigned to any CDC reunification location.

## Middle College HS Reunification

Middle College HS students are considered to be part of the general college population unless they are in a MCHS classroom during an incident. Outside of the MCHS classroom they will be part of the "General Campus Reunification" referenced above.

1. MCHS students in HS class session will reunify in their classroom unless required to move.
2. If the MCHS classroom facility is not available, then the students and staff will be relocated to either Building 43 or Building 60. This move will be directed by the MCHS faculty and staff. They will notify parents.
3. If an off-campus location is required, then the MCHS faculty, staff and children will make their way to the LDS church [located off campus](#).
4. A sworn peace officer or member of CAPS may be assigned to any CDC reunification location.

## General Campus Reunification- Cuyamaca

1. If on-campus traffic is restricted then general campus reunification will occur at the shopping center located across the street near Target.
2. If all vehicles have exited campus, then limited on-campus reunification traffic can occur via Rancho San Diego entrance only. Other campus entrances will remain closed.

3. If conditions require additional transportation resources, use the Cuyamaca list of vehicles under the resources tab.
4. If transportation to the reunification location is needed, call MTA. They can help with a shuttle service.

  - b. Ask for supervisor

### **Child Development Center Reunification**

1. CDC personnel and children will reunify at the CDC, unless required to move.
2. If the CDC is not available for reunification, then children and staff will be relocated to the EOC Staging area. Notification of this move will be posted on the entrance to the CDC, and sent via the CDC parent notification plan.
3. If an off-campus location is required, then the staff and children will make their way to the Skyline church. The MOU to use the Church is located under this tab.
4. A sworn peace officer or member of CAPS may be assigned to any CDC reunification location.
